Nixon then said that anyone in the executive branch who was indicted would be suspended from his post, and anyone convicted would be discharged." He then stated: "I have expressed to the appropriate authorities my view that no individual holding, in the past or present, a position of major importance in the administration, should be given immunity from prosecution." Nixon ended [by saying] 'I condemn any atmpmts to cover up, no matter who is involved.' With that he left the briefing room. Press Secretary Ziegler was engulfed in a storm of questions." (Emery, *Watergate*, pp.337-38).

² Possibly the meeting Kissinger is referring to was "an official visit by Italian Prime Minister Julio Andreotti", "in the middle of [which], Nixon decided to get out [in] front of Watergate. . . . The president decided to make a brief statement in the White House newsroom before reporters and TV cameras, but to take no questions." [see above n] (Emery, *Watergate*, p.337).

⁴ Leonard Garment had been one of Nixon's associates at the law firm Nixon Mudge. He then served in Nixon's White House as special consultant on domestic policy from 1969 to 1974. In the wake of the Watergate scandal, Garment filled the role of Counsel to the President. (From the bio-blurb for Garment's book, *In Search of Deep Throat*). Lukas (pp.441-442) mentions that by April 17, 1973, Garment "had taken over much of [John] Dean's legal work".

⁵ John Mitchell, Nixon's Attorney General in 1968, resigned March 1, 1972 to become director of the Committee to Re-Elect the President, resigned for 'personal reasons', July 1, 1972 (various sources). Indicted May 10, 1973 on one count of conspiracy, three counts of endeavoring to obstruct justice, and six counts of making false statements to a grand jury. Pleaded not guilty May 21, 1973. Acquitted April 28, 1974. (from Leon Jaworski, *The Right and the Power*, p.354)

⁹ In *Abuse of Power: The New Nixon Tapes*, Stanley Kutler has “edited the conversations with an eye toward eliminating what I believe insignificant, trivial, or repetitious.” (p.vii). He has an edited version of this conversation (pp.320-324). As I was transcribing Kissinger’s utterance, I wondered how Kutler heard it, figuring he probably had Kissinger saying, not “It’s impermissible to touch the Presidency”, but, due to a combination of Kissinger’s pronunciation and the overlapping breath by Nixon, had only heard “...the President”. Sure enough, that’s what he’s got. (See p.322, line 12, “KISSINGER: It’s impermissible to touch the President.”).

¹² The Teapot Dome scandal involved high government officials in the Warren Harding administration (1921-1923, noted for its record of general corruption). Albert B. Fall, secretary of the interior, persuaded President Harding to transfer the administration of the U.S. naval petroleum reserves from the secretary of the navy to Fall's department. In secret negotiations without competitive bidding, Fall issued leases which granted certain companies exclusive rights to oil and gas at the Teapot Dome reserve, Wyoming and the Elk Hills and Buena Vista Hills reserves, California. Congressional investigation (1924) revealed that Fall had received more than \$200,000 in Liberty bonds from companies benefiting by the leases. The Supreme Court ruled the contracts fraudulent and in a criminal action Fall was convicted of bribery. (From *The New International Webster's Dictionary of the English Language*, pp.440 and 698.)
